



WE ARE

ARTS SPACE PLANNERS

- We are the guardians of Edmonton's first cultural infrastructure plan. We understand what arts spaces are, what exists in our city, what's needed and what changes take place in the arts space ecosystem in Edmonton.
- We will incent the development of non-market facilities for the arts and affordable housing for artists by becoming a granting partner with arts organizations.

ARTS SPACE OPERATORS AND MANAGERS

- We own, lease, build, renovate and operate property for the benefit of Edmonton's cultural sector.
- We work with the City to develop and manage City buildings as purpose-built arts spaces.

ARTS SPACE ADVOCATES

- We are the voice of arts space issues in Edmonton. We lead the civic conversation about the value of, and need for, spaces in which artists can create, rehearse, exhibit, perform and live.
- We convene conversations with the private and not-for-profit sectors about the need for the identification, development and management of arts spaces in Edmonton.
- We shape and influence public policy and investment to support thriving cultural infrastructure and public spaces for the arts.

ARTS SPACE TRUSTED ADVISORS

- We understand the space needs of the arts community and use this insight to advise and support the City on projects involving existing or potential living and working arts spaces.
- We report to City Council annually on the space needs of the arts community, and our progress in planning, operating and managing arts spaces.

- **Equity:** We foster an equitable arts community by providing opportunities for underrepresented arts groups, ensuring fair access to spaces.
- Professionalism: We support artists' from the beginning of their journey and throughout their professional career paths by creating and maintaining spaces for their work and lives.
- **Expression:** Communities are healthier and more vibrant when artistic expression is championed, supported and shared.



The work of Arts Habitat is aligned with the City of Edmonton's City Plan, shares the ambitions of the City's IO year Cultural Plan Connections and Exchanges and activates **four actions (see right)** in that plan.

The ambitions of the cultural plan are the motivating statements that give the arts and heritage sector a strong direction of what the future will look like. They are:

AMBITIONS

ALIVE WITH ARTS AND HERITAGE

Arts and heritage are fundamental, essential elements of any operational, infrastructural public project—from refurbishments, to civic planning, to new transportation projects. Private and non-profit enterprises understand and constantly activate and rely on the arts and heritage sector as an essential part of their own endeavours. Edmonton's support and integration of arts and heritage in everything it does will be a foundational part of our civic identity.

A HUB FOR EXTRAORDINARY CREATION AND REPUTATION

Edmonton is a beacon for cultural expression; a place that invites and supports new models of working together; encourages boldness in the production of work; champions opportunities to challenge assumptions and the status quo; fosters a productive connectedness between practitioners; and lifts artists, practitioners and organizations to a level that best meets their abilities. It is an exciting ecology of creation, expression, reflection and disruption that is unique amongst cultural landscapes.


A THRIVING AND WELL-FUNDED ARTS AND HERITAGE ECOSYSTEM


Edmonton is a city that supports its cultural ecosystem with purpose, vision and flexibility. Funding models and strategies focus on fostering, attracting and retaining artists and heritage practitioners, and creating cascading, long-term impacts for the cultural ecosystem, and therefore Edmonton as a whole.

Within the cultural plan, the four actions of Connections and Exchanges that Arts Habitat has responsibility for, are:

ACTIONS

- Broker relationships with community-based entities to increase access to affordable space for arts and heritage programs, presentations and events.
- Provide expert advice on shared space models to support the integration of arts activities in neighbourhood revitalization/regeneration initiatives.
- Work with City Administration and cultural agencies to research, develop, build and seek approval from City Council for the City of Edmonton's first Cultural Infrastructure Plan.
- Provide tools, resources and advice to the cultural community in support of space audits, capital project management and asset management solutions.






